SIGN & PROSPER (CNY CAMPAIGN) 2025 TERMS AND CONDITIONS

The terms and conditions stated herein below shall govern the Sign & Prosper Campaign organised by the Organiser ("Terms and Conditions"). By participating in the Sign & Prosper Campaign (hereinafter defined), the Participant shall be deemed to have read, understood, accepted and agreed to be bound by the Terms and Conditions of the Sign & Prosper Campaign including any amendments or variations to it and unequivocally accept the same in their entirety.

1. Organiser

2. Name of the Rebate Campaign

Sign & Prosper Campaign ("Sign & Prosper Campaign")

3. Eligibility Criteria

The Sign & Prosper Campaign is open for participation to all purchasers:

4. Sign & Prosper Campaign Mechanism

- 4.4 The Organiser reserves the right to vary, postpone or reschedule the dates of the Sign & Prosper Campaign and/or extend the Sign & Prosper Campaign Period at its sole and absolute discretion.

- 7.4 The winner shall be solely responsible for and shall pay all taxes, including any sales and services tax or any tax imposed by the relevant authorities incurred in relation to the Prize (if any and where applicable).
- 7.5 By participating in the Sign & Prosper Campaign, the Participant forever releases, discharges and holds harmless the Organiser, its subsidiaries, affiliates, directors, officers and agents from and against any and all liabilities, costs, injuries, loss, or damages of any kind arising from or in connection with the Sign & Prosper Campaign or any Prize won.
